







Timing

Eligibility of costs



Preparation: costs incurred before 01 October 2021 eligible as long as related to approved additional activities (including work on procurement procedures) or preparation of application form for the call

Activity phase: costs incurred related to all activities, as per approved budget

Administrative phase: no new activities (except admin activities), possibility to pay costs from activity phase





The project submits **1 report** covering the whole period of additional activities (01 October 2021 – 30 September 2022).

The report must be submitted by the **new project end date**, at the latest (31 March 2023) – even though we will aim at finalising the reporting earlier so that partners can receive the payment.

Activities

Partners draft a territorial analysis to evaluate post-COVID needs and solutions implemented. They use a template prepared by LP covering different public building types. An online interregional exchange event is organised (M2). It focuses on sharing draft analysis results, presenting the status of partners' policy instruments and exchanging on post-COVID scenarios in different regions. Partners identify Good practices coming from organisations that used public buildings while enforcing COVID restrictions, with measures to manage energy emergency situations. REBUS stakeholder groups are enlarged with new policy / technical expertise. They are involved in regional/interregional activities and contribute to the territorial analysis. Partners share final versions of their analysis by M5 and start bilateral exchange on needs and solutions (1 online exchange per partner). LP is in charge of management and communication (contacts with PLP/website). **Outputs** 1 interregional exchange event, held online with minutes 7 Bilateral exchange online events (1 per partner)

7 regional stakeholder meetings

7 territorial analysis to identify needs and GPs

Additional call: Semester 2



Activities

Partners work throughout sem 2 on improving their policy instruments with REBUS learning.

Assuming travel is possible, the semester starts with a meeting in Durham (UK). The meeting has an interrgional workshop and the chance for further policy input with visits to Durham University, the North East and Yorkshire Energy Hub, and at least one of the Renewable Heat Projects under development in County Durham/ North East region.

Exchange activities continue, with group/bilateral meetings. Locations are fixed based on potential input to policy change. Each partner attends 1 in person bilateral exchange event (total 7) to analyse specific aspects of GPs to be adapted and transferred in their region.

Should international travel not be possible, virtual study visit/stakeholder round table/bilateral sessions are organised.

Regional stakeholder meetings are organised to share and validate interregional learning.

LP is in charge of management and communication (contacts with PLP/website).

Outputs

1 interregional exchange event (physical), with minutes7 Bilateral exchange events (physical - 1 per partner)

7 regional stakeholder meetings
