1. Main challenges to address



A European Green Deal Striving to be the first climate-neutral continent

Climate change and environmental degradation are an existential threat to Europe and the world. To overcome these challenges, the European Green Deal will transform the EU into a modern, resource-efficient and competitive economy, ensuring:

- no net emissions of greenhouse gases by 2050
- economic growth decoupled from resource use
- no person and no place left behind

The European Green Deal is also our lifeline out of the COVID-19 pandemic.

One third of the 1.8 trillion euro investments from the NextGenerationEU Recovery Plan, and the EU's seven-year budget will finance the European Green Deal.

2. Main objectives we would like to achieve

In Tuscany the new programming of European funds, currently being prepared, will broadly follow the previous one for the part on energy efficiency.

- The new calls to encourage energy efficiency in public bodies will probably be published in 2022 as at the moment the Tuscany Region has prepared the first proposal of the POR FESR 2021-2027
- The delay in the approval of the new ERDF ROP is a consequence of the delay in the approval of both the new European regulations for programming 2021-2027 and the Partnership Agreement at national level.
- The final version of the Program will be forwarded to the European Commission by December 2021.



Main objectives we would like to achieve

- Technological development and energy efficiency interventions induced by regional incentives of ERDF 2014-2020 have produced significant results and present further potential for application;
- The Tuscany Region, starting from the recent regional experience programming, intends to promote an **integrated strategy in support of sustainability and ecological transition, through ongoing actions such as the promotion of energy efficiency** (among the intervention priorities foreseen in the within this objective - OP2 - interventions will be promoted in **support of public and private entities for the rationalization and reduction of energy consumption** as well as for energy efficiency, in particular **to reduce energy consumption** and **climate-altering gas emissions** of the building heritage public and / or for public use);
- These objectives will have to be achieved in a framework conditioned by the pandemic, which has changed the way buildings are used: a new challenge for Rebus.



3. Any ideas on the type of actions we would like to implement to improve our policy

- Carefully monitor the results achieved with the previous ROP to enhance the best experiences
- Coordinate the international partnership to offer MA studies on the changed situation of public buildings, re-analyzing needs, energy and economic costs, related to home working.
- On this coordinated action we will be able to ask for the support, including economic support, from public bodies



4. Means of influencing the policy instrument

- The more efficient our analysis will be, the more we will be able to help the support policies implemented by the MA to improve the efficiency of public buildings.
- The project will therefore have to update the list of stakeholders, and provide for a close relationship with them
- National analyzes will be useful to all partners thanks to a continuous and close comparison

What do we expect from the cooperation with other partners?

- To be able to study the measures of the MA of the partner nations in relation to the new POR FESR programming
- Compare the energy efficiency measures that will be present in the partners' ROPs, and exchange the best experiences by offering them to the MAs
- If we find a shared common line we will be able to build experiences, analyzes, pilot actions that will multiply the effects of what everyone can achieve in their own situation.
- We expect and hope for a continuous exchange of experiences and solicitations.
- Let's free our wits, and maybe even our imagination
